Referenced is hereby made to a certain brokerage account owned solely by you and described in Exhibit A hereto (the "Account"), which is actively managed with full discretion and authority by Millennium Asset Management, L.L.C. (the "Millennium").

You hereby grant to Millennium and its designees the right to use, duplicate, display, transmit, communicate, distribute and otherwise disclose any and all Account records and statements, including any transactions and market positions set forth therein, whether in electronic or physical form, ("Account Records") to any person, entity or association throughout the world and perpetually for the purposes of the demonstrating and verifying the Account's investment performance and Millennium's and its personnel's investment strategy and track record.

Without limiting the generality of the foregoing, you agree that Millennium may summarize the Account Records, develop analysis of the Account Records and use, duplicate, display, transmit, communicate, distribute and otherwise disclose such Account summaries, analysis and the results of such analysis to any person, entity or association throughout the world and perpetually.

Millennium agrees to remove your name and other personal identification information ("Personal Information") from the Account Records prior to transmitting, communicating, distributing and/or disclosing the Account Records and associated summaries and analysis to prospective clients and others.

You hereby authorize Millennium, the brokerage firm where the Account is located and their respective designees to communicate (i.e., by phone, email or otherwise) with the Millennium's prospective clients in connection with the Account Records, associated summaries and analysis and Millennium's services. Without limiting the generality of the foregoing, you hereby authorize Millennium and its designees to disclose any information (other than Personal Information) related to the Account Records and associated summaries and analysis to prospective clients and others.

This letter agreement will be terminated upon the earliest to occur of: (i) Millennium's receipt of written notice of termination from you, effective 30 days thereafter; (ii) upon your receipt of written notice of termination from Millennium, effective immediately; or (iii) such other date as mutually agreed by you and Millennium.

Neither Millennium nor its affiliates, beneficiaries, beneficial owners, officers, partners, agents, employees and legal representatives (each of whom, including the Investment Manager, is an "IM Party") shall be liable for any costs, losses, claims, damages, liabilities, expenses (including reasonable legal and other professional fees and disbursements), judgments, fines or settlements (collectively, "Losses") arising out of, related to or in connection with any act or omission of such IM Party taken, or omitted to be taken, in connection with the Account or this letter agreement.

This letter agreement has been entered into in the State of California, and the laws and courts of the State of California shall govern the validity, interpretation and legal effect of this letter agreement. This letter agreement may be executed (including by facsimile or pdf) in one or more counterparts, each of which shall be deemed an original agreement, and all of which together shall constitute one and the same instrument.


